

**FIRST LINE TECHNOLOGY, LLC LIMITED ONE-YEAR WARRANTY**

First Line Technology's Warranty obligations are limited to the terms set forth below:

First Line Technology warrants that its products are free of defects in materials and workmanship under normal use and service for a period of one year from the date of purchase by the original end user purchaser ("Warranty Period"). If a defect arises and a valid claim is received during the Warranty Period, at its option and expense, First Line Technology will repair or replace it or deliver to the purchaser an equivalent product or part at no additional charge. Repair parts and replacement products are furnished on an exchanged basis and will either be reconditioned or new. All replaced products and parts will become the property of First Line Technology. First Line Technology may request that you replace defective parts with new or refurbished user installable parts that First Line Technology provides in fulfillment of its Warranty obligation. A replacement product or part, including a user installable part that has been installed in accordance with instructions provided by First Line Technology, assumes the remaining Warranty Period of the original product or 90 days from the date of replacement or repair, whichever provides longer coverage for you. Parts provided by First Line Technology in fulfillment of its Warranty obligation must be used in products for which Warranty services are claimed.

If you feel that your First Line Technology unit is defective, and wish to rely on this Warranty, the following procedure is required within the Warranty Period:

1. Contact the Authorized First Line Technology Dealer where you purchased this unit.
2. The First Line Technology Dealer will advise you on arrangements that can be made to inspect and repair your unit.
3. The First Line Technology Dealer will inspect the product and advise you whether the product is defective and, if so, may arrange for the repair of your unit without an extra charge to you.
