

DECONTECT AWARENESS PROGRAM (DAP) - 8 HOURS

COURSE DESCRIPTION: Participants will be given an understanding of the science behind First Line Technology's DeconTect products to include Dahlgren Decon and FiberTect. An overview of Hybrid Decontamination techniques will be provided, as well as hands-on practical training on mixing Dahlgren Decon. The Enhanced Decon Systems (EDS) Kit, Electrostatic Decon Kit (EDK), and Modular Decon Kit (MDK) will be introduced. A Hybrid Decontamination line will be demonstrated. This course will also include access to the Decon Field Guide app and web portal.

DECONTECT TRAIN-THE-TRAINER - 16 HOURS (2-DAY COURSE)

COURSE DESCRIPTION: Participants will be instructed in the principles and operational application of Hybrid Decontamination using FiberTect and Dahlgren Decon systems. Effectiveness against Synthetic Opioids, CWAs, BWAs, TICs/TIMs, and emerging threats will be discussed in depth. The Decon Field Guide app will be introduced, as well as instruction on dilution ratios, dwell times, and contraindications for use. Other topics include cold weather decon, post-fire decon, and low-footprint decon. Recommended SOPs will be presented, as well as integration of Hybrid Decon into existing SOPs and agency mandated procedures. Participants will demonstrate their knowledge during extensive practical exercises. Upon successful completion of the course, each student will be provided with a template lesson plan, presentation, and quick-reference book to enable them to conduct training at their agency.

COURSE DESCRIPTION: Participants will be instructed on how to properly utilize the First Line Technology's Dahlgren Decon, FiberTect, Enhanced Decon Systems (EDS) Kit, Electrostatic Decon Kits (EDK), and FastGrab to perform field decontamination of individuals and equipment exposed to a variety of dangerous contaminants including synthetic opioids. The principles of Hybrid Decontamination without external water sources will be presented. The course will include operational guidance and a refresher on mass casualty decon referencing the latest evidence-based approaches. Participants will then demonstrate this knowledge through a hands-on practical exercise simulating real-world scenarios. This course will also include access to the Decon Field Guide app and web portal.

COURSE DESCRIPTION: Synthetic Opioids such as Fentanyl and it's analogs(Carfentanil, U47700) are being encountered more frequently by first responders worldwide. These substances pose a risk of death to first responders if not correctly handled and decontaminated. This course will provide safety instructions and recommendations based on available test data, decontamination best practices, laboratory data, and lessons learned from the field. A practical portion will include mixing and utilizing Dahlgren Decon to safely neutralize Fentanyl.

DRY DECON TRAINING - 4 HOURS

COURSE DESCRIPTION: Up to 95% decon on most threats can be accomplished immediately using FiberTect. This course covers basic awareness of hazardous material threats, contaminant identification, safety precautions, and operational use of dry decon on common contaminants. Safety and decontamination measures for synthetic opioids will be covered in depth. Use of dry decontamination in mass casualty incidents and best practice updates will also be discussed. All participants will take part in hands-on decontamination exercises utilizing non-toxic simulants for common contaminants.

This course is OSHA compliant for 4-hour HazMat Awareness level training and will count towards 4-hours of OSHA compliant HazMat Operator level annual refresher training.
